LIBRARY FACILITIES

MEDICAL FACILITY

On campus Doctor is not available. However, medical aid is available on call & the cost has to be borne by the participant. Please note that Medical Expenses are not reimbursable. In case of emergency, the medical expense incurred by the participant may be reimbursed, subject to approval by Director General, NIESBUD. Relevant receipts/vouchers and a certificate from a registered medical practitioner on whose advice the treatment has been undertaken or from the concerned hospital should support all claims for reimbursement of medical expenses. The expenditure on the following items will not be reimbursed:

- Cost of food and tonics; Cost of spectacles, artificial dentures, hearing aids and orthopaedic appliances;
- Cost of anti-biotic drugs, except for the initial period of three months or when the patient develops complications and is hospitalized;
- Cost of treatment of venereal diseases, trimmers, sterility, impotency, obesity, T.B., etc and cost of dental treatment.

ALLOWANCES

FOR PARTICIPANTS
