### **Training Methodology**

NCGG uses a judicious mix of the various pedagogies to deliver the content in the most appropriate model. Some of the tools and techniques used to deliver the programme are listed below.

1. **Case Studies:** These include case studies are prepared by globally renowned academic experts. These case studies often focus on a key decision dilemma faced by the senior executive in a particular context.
2. **In-class Exercises:** In-class exercises are used by faculty to impart elements of hands-on training to participants. These include role-plays, scenario-based decision-making problems, small cases, exercises, etc.
3. **Independent Studies:** Sufficient pre-class reading material, curated videos, and case study preparation is provided to participants, these independent study elements are aimed at preparing the participants with relevant information required to participate in the classroom discussions. Faculty will provide the readings, videos, and assignments based on the topic.
4. **Lectures:** Lectures, although not very commonly used, are a very strong part of the methodology. These lectures are curated to impart knowledge to participants on topics that required specific attention to concepts.
